Chiwaukee Prairie State Natural Area is one of the largest prairies remaining in the state and one of the largest coastal wetlands in Southeastern Wisconsin. Resulting from varying stages of the post glacial lakes that historically occupied the Lake Michigan basin, Chiwaukee Prairie State Natural Area is part of a ridge and swale landform that extends south of the state line. The micro-topographical heterogeneity and proximity to Lake Michigan makes this State Natural Area a mosaic of communities including mesic prairie, dry-mesic prairie, wet-mesic prairie, wet prairie, fen, sedge meadow, shallow marsh, and oak savanna. Special concern, threatened, and endangered plants are present throughout the site. In addition, Chiwaukee Prairie State Natural Area provides habitat for multiple critical animal species as well as many species of grassland and wetland breeding birds. Parcels within the natural area are owned by the Department of Natural Resources and private landowners.

The natural area is surrounded by agriculture and residential development including the community of Carol Beach. A railroad corridor lines the entire western boundary of the natural area where several large culverts passing under the railroad drain runoff inputs of silt, sediment, and nutrients from the infrastructure to the west. As a result, populations of invasive giant reed grass (*Phragmites australis subsp. australis*) and hybrid cattail (*Typha x glauca*) are present within the complex. Chiwaukee Prairie State Natural Area is managed by the Department of Natural Resources and the citizen-based Chiwaukee Prairie Friends Group who perform herbicide applications, girdling of exotic trees, and cycled fire regimes within the natural area. However, funding limitations as well as privately owned parcels restrict the interval and area in which prescribed fire is utilized and thus, encroachment of glossy buckthorn (*Frangula alnus*), is also a management concern. Continued acquisition of the private parcels by the Department of Natural Resources or management cooperation by private landowners would be ideal.




